# An Introduction to Working with People with Intellectual and/or **Developmental Disabilities Across Health Care Settings**

#### Friday, December 15th, 2023 12:00pm-2:00pm ET

People with intellectual and/or developmental disabilities have the same health care needs as people without disabilities. However, the health care system does not adequately address their needs. Studies have repeatedly found gaps in healthcare services for people with intellectual and/or developmental disabilities, from dental care to preventative care.

This session will outline the barriers to care people with developmental disabilities face and introduce providers to working with people with intellectual and/or developmental disabilities. Two experts in the field will speak to their experience working with people with intellectual and/or developmental disabilities and what providers need to do to treat people with culturally competent care. The session will close out with a conversation with a person with lived experience so providers can hear directly from a person with a developmental disability on what they need when accessing the healthcare system.

#### James V. McDonald, MD, MPH Commissioner, New York State Department of Health

James V. McDonald M.D., M.P.H., was appointed Acting Commissioner of Health January 1, 2023. Prior to joining the New York State Department of Health in July of 2022, Dr McDonald served at the Rhode Island Department of Health since 2012. At the Rhode Island Department of Health, he served in multiple roles including, Interim Director of Health, Chief Administrative Officer of the Board of Medical Licensure and Discipline, Medical Director for the COVID unit, as well as the Medical Director for Center for Customer Services and the Drug Overdose prevention program. He was also a member of the Governor's task force on Preventing Overdose deaths. Dr. McDonald has faculty appointments at the Brown School of Public Health as well as the Warren Alpert Medical School of Brown University. Dr. McDonald earned his M.D. from Loyola Stritch School of Medicine in Chicago, his pediatric residency in the US Navy, and his preventive medicine residency from the State University of New York. He earned is MPH from the University of North Carolina in Chapel Hill. He earned his B.S. in Biology from Siena College, Dr. McDonald is board certified in pediatrics as well as preventive medicine. His diverse career includes officership in the U.S. Navy, as well as private practice in rural areas where health care shortages existed. Dr. McDonald also served in the Indian Health Service in in the Navajo Nation, serving as Medical Director of Outpatient Medicine in Chinle, Arizona


## Dr. Vincent Siasoco, MD, MBA

Kennedy (RFK) Children's Evaluation and Rehabilitation Center at Montefiore (CERC) and Director of Community Engagement/ Demonstration Projects at the RFK University Center for Excellence in Developmental Disabilities (UCEDD). He is the Faculty Advisor of the Student Chapter of the American Academy of Developmental Medicine and Dentistry at Einstein, Dr. Siasoco received his MD degree from the University of Santo Tomas Faculty of Medicine and Surgery. He completed his Family Medicine residency training at St. Clare's Hospital (Now part of Ellis Hospital). He received his MBA from the Robert Willumstad School of Business at Adelphi University and is a member of Beta Gamma Sigma. Dr. Siasoco is on the Board of Directors at the American Academy of Developmental Medicine and Dentistry and a member of the Editorial Advisory Board of Helen: The Journal of Human Exceptionality, He is a Clinical Director for Special Olympics and Chair of the Special Olympics New York Health Advisory Council. Izel Obermeyer, Ph.D., was appointed Chief Clinical Officer at the Westchester Institute for Human Development (WIHD), in 2020.
